Over the past couple of months, we have been involved in a few things. During September we had a ceremonial in Lewiston. We had 7 people who went through the hot sands. I would like to congratulate all the new Nobles. We look forward to your participation. We had our 4th quarter meeting the first of November where we did cold sands on one new Noble. I also gave Chief Rabban Kirk authorization to perform cold sands on another new Noble. Wouldn't it be great to end the year with more Nobles than we had at the beginning of the year?

We did leave out one important thing at our last quarterly meeting, and that was to vote on dropping our members who are two years behind on dues. We have six Nobles in that category. We are hoping to save a couple of them. Therefore, I have called a special meeting for 10:00 a.m. on December 14 for the singular purpose of voting to drop the Noble who are in arrears two years. We will conduct no other business at that meeting, so it will only take about 30 minutes. The uniform for that meeting is "come as you are." The meeting will be held at the Coeur d'Alene Shrine Club. We need enough people to show up for a quorum.

At the quarterly meeting we voted to keep all the dues collected for next year in next year's budget and stop the deficit spending that we have been doing for many years. To do that we approved to use up to \$25,000 of the investment fund interest that we have collected over the years. we have now estimated that we will not need that much. Any funds that are not legitimately used will stay in the investment account. We are not going to do any frivolous spending just because we approved up to a certain amount. There are a lot of Nobles who have not paid their 2019 dues yet, so we are way behind on the income side of our budget. Our donations from the clubs and units are down a bit this year also. I believe we will come in under budget on the spending side also. I do not believe we will spend all the money that was projected in the budget.

As always thank you all for the support over the past year. My time as Potentate has been priceless.

From Your Recorder

Greetings Nobles,

In preparation for year's end and the upcoming annual meeting in January, please take notice of the following:

Nobles whose dues are 2 or more years in arrears will be automatically suspended by Imperial and dropped from the rolls as of December 31, 2019. If you are one of these Nobles, we do not want to lose you! If you need help, please contact me or Michelle at the Shrine office. Nobles, if you know of a member who is in arrears and needs help, please contact him and/or or his Club/Unit to see what can be done to help. Michelle can take credit card payments for dues over the phone.

Also, if you haven't paid your dues for 2020 yet, please do so. The Temple relies on your dues to pay the bills beginning the first of the year. Remember, we can take payments for dues! And, we can take your credit card payments over the phone.

§ 325.11 Election Regulations.

(a) Electioneering. A candidate for an elected office in a Shrine temple may print, publish and circulate during the year he is seeking the elected office, a résumé consisting of his educational background, his vocational history, and his Masonic and Shrine record. Except as provided in the prior sentence, the printing, publication, circulating or distribution of resolutions, letters, telegrams, tickets, email or other devices, by a unit, club, Noble, or group of Nobles, suggesting, recommending, opposing, or containing the names of proposed candidates for prohibited. office in the temple is (b)Expenditures Prohibited. The expenditure of money for gifts, favors, or entertainment on behalf of a candidate

for elected office is prohibited.

(c)Violation. For any violation of (a) or (b), the Imperial Potentate may suspend any offending Noble, and he may declare the election of the officers void and order a new election.
(d)Notice. At least one week prior to the annual meeting or any election, the temple Recorder shall mail to each member a notice thereof containing this section.

I hope everyone had a great year and I look forward to seeing you all at the Annual Meeting in January.

Notice of Special Calam Shriners Temple Meeting

A Special meeting of Calam Shriners will be held on December 14, 2019 at 10:00 AM at the CDA Shrine Club in Hayden for the sole purpose of voting on dropping from the rolls those members who are 2 or more years in arears in their temple dues, per capita and/or hospital assessments.

Shriners International will automatically drop these members based upon their non-payment status in WebFez. However, Imperial bylaw requires Calam still hold a vote of the membership to drop them. A Temple is not allowed to carry members in arears and must either vote to allow them to drop automatically in the system or remit their dues from Temple monies. We have a total of 6 regular members to be automatically dropped for their entire dues and 2 Temple Life Members scheduled to be dropped for non-payment of Per Capita. A list of the members in arears may be obtained form the Recorder's office and will be read at the meeting before the vote.

No other business may be conducted during this meeting. A quorum of seven members of Calam in good standing must be present and must include either the Potentate, Chief Rabban, Asst. Rabban or a Past Potentate. This is a housekeeping matter that is required by the bylaws. If you are available, please attend.
