SUBJECT: Excusal for 2021 Imperial Session

At the 2021 Imperial Session, a motion was made and adopted which provides that Members of the Colorado Corporation who did not register at the 2021 Annual Meeting, or who are not emeriti members, have their membership terminated if they do not provide a written request for excusal setting forth good faith reasons supporting their request to the Executive Vice President of Shriners International on or before December 31, 2021.

Therefore, if you wish to maintain your membership in the Colorado Corporation, you should immediately provide a written request setting forth good faith reasons supporting your request for excusal to the following: officeoftheexecutive@shrinenet.org.

Because of the travel restrictions and health concerns caused by the global pandemic, excusals from attending the 2021 Annual Meeting will be liberally granted. If you have not already done so and received a response, you are encouraged to immediately submit your written request for excusal.

Because ample time is provided for the submission of your excusal, requests received after December 31, 2021, will not be considered. Those who did not attend the 2021 Annual Meeting, and who did not timely submit an excusal, will be terminated from membership in the Colorado Corporation.

My friend, Michelle Novelle, took a lot of flags and walked ahead of Jerry and I, us riding in his ATV, she went straight to the people obtaining most of the sales of the flags. LADIES CORNER

Hi Nobles and Ladies!

First of all, thank you for your assistance in raising awareness and funds for the Rising Star Program of 2020-2021 First Lady, Alice Smith. Calam Temple donated \$200 to her project. Overall, for the year, Sister Alice raised \$460,000 and is hoping to reach half a million in donations as more contributions are still arriving.

I am excited to share that the 2021-2022 First Lady, Debby Bailey's program is called Transforming Lives. The focus for her fundraising will be for children suffering from Scoliosis. Scoliosis is an extremely common condition that, if left untreated, can have debilitating impacts on a child's life.

There are several areas of treatment for children with Scoliosis.

Casting and bracing: Serial casting is often an effective option to slow progression of a spinal curve. A plaster cast gently and precisely helps straighten the spine.

Spinal fusion: In fusion surgery, screws and rods are used to correct the curve, then bone grafts fuse the spine to hold the correction in place.

Vertebral body tethering (VBT): This process was developed by the medical team at the Shriners Hospital in Philadelphia, Pennsylvania. This technology helps correct the scoliosis while allowing a more natural motion, unlike fusion surgeries.

Another area of concern for children with Scoliosis is the level of exposure to radiation that these children experience throughout their young lives. The EOS imaging system used at Shriners Hospitals emits much less radiation than standard X-rays or CT scans. EOS systems produce high-quality 2D or 3D images that deliver very precise measurements, helping the medical teams to craft in-depth analysis and personalized treatment plans.

At this time I will continue to offer the Star Pins to raise money for the Transforming Lives Program. The emblem for this program is the butterfly.

There may be a butterfly pin available soon. I will keep you posted!

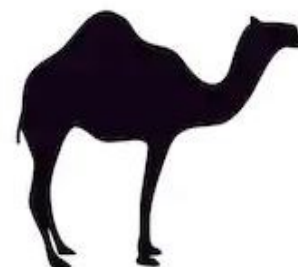
